I. Introduction 1.1 Overview of Performance Management at the Office for Victims of Crime

The purpose of this document is to assist Transforming Victim Services (TVS) grantees in completing and submitting accurate performance measure data in the Office for Victims of Crime (OVC) Performance Measurement Tool (PMT). OVC uses grantee-reported data in reports and publications to educate key stakeholders and the public on the value of OVC's grant programs and OVC-funded victim services across the country. OVC also uses the data to respond to inquiries from Congress and other government agencies, the media, Freedom of Information Act (FOIA) requests, organizations in the victim services field, and other entities. Therefore, it is imperative that grantees make every effort to report performance measure data accurately, thoroughly, and consistently.

This document is a companion to the TVS Performance Measures Questionnaire document and further explains what data to report, and when, where, and how to report data.

1.2 2019 Updates

Data Validations

OVC added new validations to the PMT system to help with the data reporting and verification process, particularly in the Victim Services question bank.

1.3 Grantee Roles and Responsibilities for Reporting

As a grantee, your role in performance measurement reporting includes the following-

- **Identifying** individuals in your organization who should have access to the PMT and maintain your organization's profile page.
- **Collecting** all data required in the PMT and ensuring its accuracy; asking questions if you are unsure how to report any data.
- **Submitting** quarterly and semiannual data via PMT and the Grants Management System (GMS) by the deadlines established for your program.
- Attending training on performance measures offered by OVC and reviewing resource materials.
- **Clarifying** and **updating** data in response to any inquiries from OVC.

1.4 Role of the Office for Victims of Crime Staff

OVC Grant Managers and members of OVC's Performance Management Team perform the following activities related to performance measure data—

- Identify appropriate performance measures for grantees to report based on program goals and anticipated outputs/outcomes.
- Provide training and technical assistance (TTA), including helpdesk support, on using the PMT system and entering performance data.
- Review data entered by grantees and subgrantees to promote consistency and accuracy.
- Analyze data to develop grant program reports and respond to data inquiries.

1.5 How the Office for Victims of Crime Uses Transforming Victim Services Data

Data reported by grantees allows OVC to demonstrate the value and specific benefits of the program to government agencies, the victim services field, the general public, and other stakeholders. OVC uses the data provided by TVS grantees to generate an annual report on the program, and to respond to specific inquiries.

1.6 How Grantees Can Use Performance Measurement Tool Data


Grantees can use data to monitor progress and determine whether the organization is on track to meet project goals and objectives. Grantees can also use data for strategic planning by evaluating past performance and setting reasonable goals, objectives, and targets for future programs.



II. Accessing the Performance Measurement Tool: Creating a New Grantee Point of Contact

2.1 Gaining Access to the PMT for the First Time

As a new grantee point of contact (POC), the **OVC PMT Helpdesk** or the existing grantee POC for your organization can add you to the PMT.


3.1 Log into the Performance Measurement Tool Site

3.2 Resetting Passwords

PMT passwords do not expire; the system will not automatically prompt you to update your password. You can reset your password if desired for enhanced security.



Passwords must conform to the following requirements-

- At least 12 characters in length
- Contains alpha characters of both upper and lower case—at least one of each
- Contains at least one number
- Contains at least one special character

If you forget your password—

- 1. Enter your user name and leave the password field blank.
- 2. Select Forgot Password.
- 3. Enter and submit the answer to your challenge question.
- 4. Enter a new password. Please remember to adhere to the password guidelines.
- 5. Click the **Update** button at the bottom of the page.

3.3 Menu Bar

Once you log in, you will see the Profile page. The top menu bar can be used to navigate between the different sections of the site.



From this screen, you can also view details on specific award amounts and view start and end dates.

3.7 Enter Data Tab

PMT requires a grantee to enter data for each quarter before the grantee has the option of entering data for the following quarter. For example, a grantee must enter data for the April–June 2019 reporting period before the dropdown list displays an option for the July–September 2019 reporting period.

If you do not see the current reporting period in the dropdown list, confirm that all previous quarterly reports have been entered (check report submission status via the Reports tab).

IV. Reporting Schedule: Office for Victims of Crime Deadlines



Performance data is due in the PMT on a quarterly basis. Grantees that do not submit data in the PMT on time may receive a notice from their OVC Grant Manager to ensure compliance with the quarterly grant reporting requirements. Reporting due dates are listed below.

4.1 Submitting the Semiannual Performance Measures Report in GMS

A semiannual report should be generated for any award that was active for any portion of the January 1–June 30 reporting period or the July 1–December 31 reporting period. After the April–June and October–December quarters, grantees will be prompted to respond to a set of narrative questions. Grantees will then generate a Semiannual Performance Measures Report in the PMT that aggregates data from the prior 6 months. To comply with GMS requirements, the report must be submitted into GMS, a separate reporting system, by January 30 and July 30.

4.2 Closeout Reporting in the PMT

Grantees who are closing out their award, whether at or before the grant period end date, should follow the steps below to close out—

- Step 1: Continue to report for any portion of the reporting period during which your award is still active. For example, if your award ended on May 31, you would have to complete reporting for activity that occurred from April 1–May 31 as part of the April 1–June 30 reporting period.
- Step 2: If your award is ending during the January–March or July–September reporting period, contact the OVC PMT Helpdesk to request a Word document of the semiannual narrative questions. (If your award is ending during the April–June or October–December reporting period, the PMT system will automatically prompt you to complete the semiannual narrative questions.)
- **Step 3:** After your data is complete, navigate to the Reports tab in the PMT and select the Federal Award you wish to close out.

Step 5: If your award is ending during the January–March or July–September reporting period, upload the Excel spreadsheet (with your final quarter's data) and a copy of the semiannual narrative question Word document to the GMS. If your award is ending during the April–June or October–December reporting periods, upload your semiannual report PDF to GMS as you normally would.

4.3 Reporting Schedule: Subgrantee Reporting

If you are an organization that subgrants a portion of your award to other partners, please follow the steps below for subgrantee reporting—

- **Step 1**: Provide each of your subgrantee organizations with a fillable PDF copy of the TVS questionnaire. The document will allow subgrantees to record their data for the 6-month semiannual reporting period.
- **Step 2:** Share training resources developed by OVC with your subgrantees.
- **Step 3:** Communicate directly with your subgrantees regarding internal data submission deadlines and processes.
- **Step 4:** Collect the fillable PDF from your subgrantees and submit into GMS along with your semiannual PMT report.

Ask OVC...

Q: What is the difference in grantee vs. subgrantee reporting? Do grantees consolidate their numbers, upload subgrantee information biannually, or do both?

A: Quarterly reporting in the PMT is based on grantee activities. If grantees have subgrantees, grantees should provide each subgrantee a copy of the **TVS Performance Measure Questionnaire fillable PDF.** Subgrantees complete the SAME question banks as grantees. Subgrantees report semiannually (January 1–June 30 and July 1–December 31).

After the April–June and October–December quarters, grantees will be prompted to respond to a set of narrative questions and then generate a **Semiannual Performance Measures report** in the PMT that aggregates data from the prior 6 months. To comply with GMS requirements, the PMT report (with the grantee's activity) and each subgrantees completed fillable PDF must be submitted into the GMS, a separate reporting system, by January 30 and July 30.

4.4 Delayed Reporting Reminders

If you receive a notice indicating you have not yet completed required reporting, please log into the PMT, navigate to the reports page, and check the data entry status. If you have multiple awards, check the status of each award. Data entry status options include—

- Not Started (no data has been saved)
- In Progress (some data has been saved; the "Complete data entry" box has not been selected)
- Complete (the "Complete data entry" button has been checked and saved)

Ask OVC...

- **Q**: Are we able to go into the PMT site to review the system prior to our report due dates? Just to get familiar with the navigation?
- A: Yes. The new award POC will receive an email from the OJP PMT Administrator stating they have been granted access to the OVC PMT. The POC should add a user profile for any other staff who will be using the PMT system. Individuals have access to the system upon setting up their accounts.

New awards will not be able to access data entry pages until the start of the first submission period of the award. Grantees can refer to the screen shots in this user guide and view recorded trainings to see how data entry pages are displayed. See 8.2 Recorded Webinar Trainings section of this user guide for information about accessing the recorded PMT Webinar Series trainings.

V. Performance Measure Question Banks

The TVS portion of the PMT system is comprised of seven question banks that collect data on different types of activities, including training, technology development, and strategic planning. OVC Grant Managers and OVC's Performance Management Team select which question banks grantees respond to based on the type(s) of activities the grantees will perform. These assignments are made prior to the grantee's first reporting period, and remain constant throughout the life of the award. While rare, OVC may determine that additional question banks should be added as a result of special circumstances.

Grantees may respond to one, several, or all of the question banks. When grantees login to the PMT system, they will see only the performance measures for their assigned question banks. Grantees are expected to provide a response for each question in the assigned question banks and shared measures. If a specific question does not apply, please enter "NA" and explain this response in the space provided.

Grantees should only report data on activity supported by their TVS award; an activity not supported by their TVS award is not to be reported in the performance measure fields in PMT.

TVS performance measures are grouped into several question banks:

- I. Training
- II. Technical Assistance
- III. Technology Developments
- IV. Data Gathering
- V. Collaborative Partnerships
- VI. Strategic Planning
- VII. Victim Services

Shared Measures:

- C. Planning Activities, Policy & Procedural Changes

5.1 Question Bank Navigational Menu

When grantees navigate to the Enter Data section, the secondary navigational menu will show ONLY the question banks assigned to that grantee. Grantees must enter performance metrics for all questions that appear. Some question banks include baseline questions that are answered one time during the first reporting period of the grant. You will not be required to report on those baseline questions again after the initial response.

5.2 Grant Activity

Grant activity is defined as any proposed activity in the OVC-approved grant application that is implemented or executed with OVC grant funds.





Q: If a victim seeks services for the same type of victimization, such as domestic violence, on multiple occasions during the quarter, are they reported one time for domestic violence, or are they counted each time they seek services?

A: A person may be victimized over a long period and may suffer many individual assaults; that victim is still presenting a single victimization type—in this example, domestic violence—and you would report the victimization type one time. The intent of this question is to capture how many people present with each victimization type during the reporting period, not to measure how often services were provided; that topic is addressed in the Direct Services section (Question 8).

Q: Are we able to serve all of these victimization types under this grant?

A: OVC discretionary grant programs sometimes have a primary goal of supporting a specific type of victim, such as children who are victims as a result of the opioid crisis. However, OVC recognizes that victims may experience multiple types of victimization.
